



CONSOLIDATED FUND OF TEXAS.

his heirs, executors, administrators or assigns to ONE SHARE, of the sum of ONE HUNDRED DOLLARS, in the CONSOLIDATED FUND of Texas, created by an act of Congress entitled "An Act to authorize the consolidation and funding of the public debt," passed on the 7th day of June, 1837. TRANS-FERABLE by the said *[Name]* his legal attorney or representative, on the *[Name]* the Stock Commissioner only; and at any time within thirty days of the day on which interest may fall due: and bearing an interest of 10 per cent. per annum, payable at the *[Name]* this Republic on the 1st day of September, 1838, and semi-annually thereafter at the convenience of the Government at any time after the 1st day of September, A. D. 1842.
