War Department, A. G. O., May 2, 1930. To the Adjutant General, State of Texas, Austin, Texas.

1. The records on file in my office show that one A. N. Fulbright, private, Co. F, 29 Regiment Texas Cavalry (De Morse's Regiment) C. S. A. was mustered into service July 20, 1862 at Clarksville, Texas. His name is not borne on the subsequent roll of the company on file in my office which covers the period for May and June, 1863, and no later record of him has been found.

2. The records also show that one Peat Fulbright (name also borne as Pete Fulbright but not as Peter Fullbright) Co. F, 29 Regiment Texas Cavalry (De Morse's Regiment) C. S. A. was appointed 1st Lieutenant July 20, 1862, and was mustered into service on the same day at Clarksville, Texas. The company muster roll for May and June, 1863, (latest on file) shows him present. His name also appears on a regimental return for the month of April, 1865, which shows him present at camp near Hempstead commanding the company. No later record of him has been found.

3. The records also show that one Martin A. Fulbright, Co. F, 29 Texas Cavalry (De Morse's) C. S. A., enlisted June 20, 1862, in Red River County; was mustered into service July 20, 1862, at Clarksville, Texas. The last number roll of the company on file which is for May and June, 1863, shows him present. No later record of him has been found.

4. No record has been found of the service of a man named Martin fulbright in this organization.

5. The name H. S. Fulbright has not been found on the only roll of Co. K, 29 Regiment Texas Cavalry (De Morse's Regiment) C. S. A. on file in my office which covers the period for May and June, 1863. The records show, however, that one S. Fullbright, private, Co. F, 29 Texas Regiment was severely wounded in an engagement at Cabib Creek, Indian Territory, September 19, 1864. The name H. S. Fulbright, rank not shown, Co. K, 29 Regiment Texas Cavalry (De Morse's Regiment) C. S. A. appears on a regimental return for April, 1865, which shows him absent with leave from March 31, 1865, for 36 days by virtue of General Order No. 17, Department Headquarters. No additional record of him has been found.

6. The records show that one James Fulbright, private, Capt. Miles A. Dillard's Company K, 9th (Young's) Texas Infantry (Maxey's Regiment) C. S. A. enlisted September 28, 1861, at Tollets Prairie for 12 months, and was mustered into service December 1, 1861, at Camp Rusk, Lamar County, Texas. His name is not borne on subsequent rolls of the company which cover in part the period from July, 1862, to April 5, 1864. However, the name J. Fullbright, private, Co. K, 9th Regiment (Young's) Texas Infantry, C. S. A. appears on a regimental return for the month of April, 1862, which shows that he died April 1st Burnsville.

7. The records show that William Fulbright, private, Co. K (Capt. Miles A. Dillard) 9th (Young's) Texas Infantry (Maxey's Regiment) C. S. A. enlisted September 26, 1861, at Tolla's Prairie and was mustered into service at Camp Rusk, Lamar County, Texas, December 1, 1861, and that he was discharged July 3, 1862, at Tupelo, Miss., by reason of disability.

8. The records show that John Fulbright, private, Co. B, (Capt. Smith Ragsdale) 9th Regiment (Young's) Texas Infantry (Maxey's Regiment) C. S. A. enlisted October 9, 1861 at Clarksville, Texas, and was mustered into service November 26, 1861, at Camp Rusk, Lamar County, Texas. His name is not borne on the subsequent muster rolls of the company on file which cover in part the period from July 18, 1862, to April 5, 1864. However, the name J. Fullbright, private Co. B, 9th Regiment (Young's) Texas Infantry, C. S. A., appears on a regimental return for the month of March, 1862, which shows that he died March 2, at Iuka, Miss., of pneumonia.

9. The records show that C. H. Fulbright, private, Co. B, (Capt. Smith Ragsdale) 9th Regiment (Young's) Texas Infantry (Maxey's Regiment) C. S. A. enlisted October 9, 1861 at Clarksville, Texas, and was mustered into service November 26, 1861, at Camp Rusk, Lamar County, Texas, and died March 7 at Iuka, Miss., of pneumonia.

10. The records show that R. H. Fullbright, 2nd Lieutenant, Co. D, 20 Regiment Texas Infantry (also known as Elmore's Regiment) C. S. A., was elected March 31, 1862, at Owensville, and was mustered into service April 15, 1862 at Camp Travis, Hampstead, Texas, and that he resigned May 4, 1864. He was reinstated on July 28, 1864, and was furloughed on August 29, 1864, for 25 ~~xxxx~~ days. His furlough was subsequently extended to November 15, 1864, and lastly to December 1, 1864. The regimental return for December, 1864, shows him absent and no later record of him has been found.

11. The collection of Confederate records on file in the War Department is incomplete, and the failure to find a complete record of any person thereon is by no means conclusive proof that such person did not serve at some time not covered by the records on file.
