 citizen of this State, have not fought a duel with deadly weapons, nor have I acted as second in carrying a  
 challenge or aided, or assisted any person thus offending. And I furthermore swear that I have not direct-  
 ly nor indirectly, paid, offered or promised to pay, contributed nor promised to contribute, any money or valu-  
 able thing, or promised any public office or employment, to secure my appointment. So help me God.
